Vs



2. The appeal was taken up with CPIO and has been examined with the available records. It has been observed that CPIO has provided the available information. Further it is informed that the decision to include health star rating was taken in the meeting held on 15.02.2022 as per the minutes of the meeting which is already available on the FSSAI website. A copy of the file noting concerned with the minutes of the meeting held on 15.02.2022 is also enclosed.

3. Further, it may also be noted that as per Department of Personnel, Public Grievances & Pensions OM dated 28th November, 2013; Public information officers are not supposed to create information; or to interpret information; or to solve the problems raised by the applicants; or to furnish replies to hypothetical questions.

Subject: Minutes of the meeting held on 15.02.2022 on Front-of-Pack Labelling-reg.

It may be recalled that the stakeholders' meeting on FOPL under the chairmanship of the then Chairperson, FSSAI was held on 30.06.2021, wherein the following was decided:

- a) The Scientific Panel to undertake review of food categories and thresholds for FOPL.
- b) FSSAI to commission a national-level survey to analyze major FOPL models that are available across the globe with the objective to identify ease of understanding and behavioral change of Indian consumers.

2. In line with the decisions of the aforesaid meeting, the Scientific Panel recommended two categories, i.e. Food and Beverages and thresholds for nutrients of concern as well as positive nutrients for these two categories. Further, a study was also commissioned through IIM, Ahmedabad, who submitted their report to FSSAI.

3. Accordingly, a meeting was convened on 15.02.2022 with the concerned stakeholders to decide remaining issues related to Front-of-Pack Labelling under the chairmanship of CEO, FSSAI. The industry associations, consumer organisations, representatives from WHO and MoHFW, Scientific Panel Members attended the meeting through virtual mode. The recommendations of the Scientific Panel on Labelling and Claims/Advertisements and findings of IIM, Ahmedabad's report were presented in the meeting and are also placed under correspondence.

The draft minutes of the meeting are placed at DFA/5686 for consideration and approval please.
